- (vi) Diligently read and review and inquire about the material that affects the Foundation
- (vii) Actively work to engage community members and networks with the Every Ribbon Counts Foundation
- (viii) Continually work to expand the mission and vision of the Every Ribbon Counts Foundation and share social media posts.
- (ix) Maintain fiduciary responsibility when handling finances and exercise a degree of care, caution, and diligence when working with finances and funds connected with the Every Ribbon Counts Foundation
- (x) May not seek to derive private gain from business transactions that involve the nonprofit.
